### Madison County High School Weight Room Flooring and Equipment Installation

Madison County Charter School System (Owner) is requesting proposals for flooring installation and weight room equipment for the Madison County High School Weight Room. Madison County High School is located at 600 Madison Street, Danielsville, GA 30633. The project will consist of installing appropriate flooring, “outfitting” and installing weight room equipment as well as providing all necessary accessories for the equipment. Double sided weight rack equipment is desired. This work is scheduled to begin as soon as possible with a final project completion the summer of 2023.

The objective is for vendor to provide quality product and installation for best value. Only qualified vendors or firms with prior experience on projects such as this should submit options in response to this request. The Madison County Charter School System reserves the right to reject any and/or all bids wherein its judgement, it will be in the best interest of the school district and award this contract to the vendor who in the school district’s opinion is most responsive and responsible, and will perform in the best interest of the district.

- The bidder and manufacturer representative responsibilities to Madison County Schools include, but are not limited to, handling any problems with products supplied and any necessary instruction on use and upkeep. Providing complete warranty documentation for products.
- The bidder must be bonded and insured.
- All Vendor packet information must be submitted as requested in the bidding documents
- Vendor must provide 2 letters of reference to similar scope of work.
- Proposals must be valid for a period of 90 days after bid opening.
